### **SCADA Administrator**

Reporting to the Manager IT Services, the successful candidate will be responsible for:

- Planning, designing, installing, configuring, maintaining, and optimizing hardware, software, and communication links while ensuring minimal network downtime;
- Diagnosing, resolving, and documenting SCADA infrastructure hardware and operating system problems in a timely and accurate fashion, and providing end user support where required.
- Following relevant NERC CIP compliance guidelines and ensure compliance with CUC IT Governance frameworks during the implementation and maintenance of systems.
- Liaising with application/hardware providers such as OSI, Dell and internal customers to ensure all applications through vendor/internal maintenance programs are being kept up to date.
- Using network monitoring software to receive alerts and monitor the status of servers, workstations, and IP based SCADA equipment and to take appropriate action to maintain within specification.
- Receiving and responding to incoming calls, and/or e-mails regarding SCADA infrastructure problems; resolving and updating relevant Help Desk ticket(s) in a timely manner.
- Standardizing schematics, programs and components; creating and/or updating documentation, diagrams, flow charts, technical documents, etc.
